ORDER

Government of India in its letter read as 1st paper above have released an amount of Rs.87,54,18,000/- (Rupees Eighty seven crore fifty four lakhs and eighteen thousand only) as Central Assistance to State of Kerala as Central assistance for implementation of the MGNREGA for the financial year 2015-16.

2. Government, having examined the matter in detail, are pleased to accord Administrative Sanction for the release of an amount of Rs.87,54,18,000/- (Rupees Eighty Seven Crore Fifty Four Lakhs and Eighteen Thousand only) being the Central Assistance under MGNREGA for the financial year 2015-16 to the state level implementing agency as detailed below:

3. The Commissioner, Rural Development Department is authorised to transfer credit the amount to the Spl.TSB account No. 89 at District Treasury, TVPM. after ensuring sufficient budget provision. The withdrawal of fund from TSB account should be done only with the concurrence of Finance Department.

4. The Project Directors, MGNREGA shall ensure that the fund released is utilized as per the conditions stipulated in the orders releasing funds by the Ministry of Rural Development, Government of India, read as 1st paper above.

5. This transfer of fund is exempted from all treasury restrictions
