ORDER

As per Government orders 1st, 2nd, 3rd and 4th read above Government have accorded Administrative Sanction and Special Sanction for One Time Maintenance of Village Roads/Other District Roads in various roads divisions in the State and has accorded sanction to incur expenditure under the head of account 3054-04-196-39 (NV) for District Panchayats and 3054-04-198-39(NV) for Village Panchayats. In the second batch of SDG 2015-16 Government have provided an amount of Rs. 75 Crore under the head of account 3054-04-196-39 and Rs. 100 Crore under the head of account 3054-04-198-39 to incur expenditure towards One Time Assistance for the maintenance of Village Roads/Other District Roads of Local Self Government Institutions.

2. Chief Engineer (Roads and Bridges) vide the letter read above has furnished Division wise details and requirement of funds to be deposited for the execution of work under One Time Maintenance of Village Roads/Other District Roads.

3. Government after having examined the matter in detail are pleased to accord sanction to transfer credit an amount of Rs. 100 Crores (Rs. One Hundred Crores only) from the head of account 3054-04-198-39 (NV) and Rs. 51 Crores (Rs. Fifty One Crores only) from the head of account 3054-04-196-39 (NV) and deposit to the head of account 8443-00-108- Public Works Deposit for utilizing the same as per the following detailed Division wise statement.
