ORDER

Government of India in its letter read as 1st paper above, have released an amount of **Rs.1,39,00,000/-** (Rupees One Crore Thirty Nine Lakhs only) as Central Share towards administrative cost for implementation of DDU-GKY (NRLM) for the year 2015-16. The above fund along with corresponding state share have to be released to SRLM Kerala Kudumbasree which is the State Level implementing agency. The funding pattern between centre and the State is 60:40.

2.Government are pleased to authorise the Commissioner, Rural Development Department to release an amount of Rs. 2,31,66,667/-(Rupees Two Crore Thirty One Lakh Sixty Six Thousand Six Hundred and Sixty Seven Only) to SRLM Kerala Kudumbasree being the Central and State share under DDU-GKY (NRLM) for the year 2015-16 as detailed below:-

3. The Commissioner, Rural Development Department will draw the amount from the treasury and release the same to SRLM Kerala Kudumbasree as instructed in the letter of the Ministry of the Rural Development, Government of India read as 1st paper above, after ensuring sufficient budget provision.

4. This transfer of fund is exempted from all the existing treasury restrictions.
