**ORDER**

As per Government Order read above, Government have launched 'Rubber Production Incentive Scheme (RPIS)' in association with Rubber Board for providing support to the rubber farmers and improving the market price of rubber. As per this scheme, subsidy is being directly transferred to the bank account of the rubber farmers through DBT on the basis of grower confirmation and verification of sales bills by officers of Rubber Board. The Chairman, Rubber Board has reported that Rubber Board has redeployed its officers to various Regional Offices for clearing the pendency of grower confirmation under 'Rubber Production Incentive Scheme (RPIS)' and requested to provide an amount of Rs.6,18,400 incurred towards deployment of officers for grower confirmation vide letter cited.

2. Government, after examining the matter, are pleased to sanction an amount of **Rs.6,18,400 (Rupees Six Lakhs Eighteen Thousand and Four Hundred Only)** to the Rubber Board for the expenditure incurred for deployment of Rubber Board's officers for grower confirmation under 'Rubber Production Incentive Scheme (RPIS)'.  
3. Sanction is also accorded for withdrawing **Rs.6,18,400 (Rupees Six Lakhs Eighteen Thousand and Four Hundred Only)** from the Special TSB Account No.242 maintained at District Treasury, Thiruvananthapuram for effecting payment to Rubber Board, Kottayam by way of RTGS/DD.


