ORDER

Government of India in its letters read as 1st and 2nd papers above, have released an amount of **Rs. 1,77,45,000/-** (Rupees One Crore Seventy Seven Lakh and Forty Five Thousand Only) as Central Share towards third instalment under SCP (NRLM) and **Rs. 1,76,32,000/-** (Rupees One Crore Seventy Six Lakh and Thirty Two Thousand Only) as Central Share towards third instalment under TSP (NRLM) for the year 2015-16. The above fund along with corresponding state share have to be released to the Executive Director, Kudumbashree. The funding pattern between Centre and the State is 60:40

2. Government are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs. 5,89,61,667/-** (Rupees Five Crore Eighty Nine Lakh Sixty One Thousand Six Hundred and Sixty Seven Only) to the Executive Director, Kudumbashree, Kerala being the third instalment of Central and State Share under **National Rural Livelihoods Mission/Aajeevika** for the year 2015-16 as detailed below:-
