#### ORDER

As per the Government orders read from 2<sup>nd</sup> to 5 th, Government have released an ₹ 169.2 Crore for all the Members of Legislative Assembly including nominated Member as the balance allocation of 2014-15 and the allocation for the financial year 2015-16 for MLAs.But the District Collectors of Development Fund Thiruvananthapuram, Kollam, Palakkad, Malappuaram, Kozhikkodu and Wayanad have failed to transfer credit the final release of allotted amount vide read 5 th Government Order.

2.Government are now pleased to release an amount of ₹ 17.25Crore ( Rupees Lakh Only) to the District Collectors of Twenty Five Crore and as detailed in Thiruvananthapuram, Kollam, Palakkad, Malappuaram, Kozhikkodu and Wayanad the list appended to this order being the arrears of the allotment for the year 2015-16 under the Special Development Fund for Members of Legislative Assembly.

3. The District Collectors Thiruvananthapuram, Kollam, Palakkad, Malappuram, Kozhikkodu and Wayanad will transfer credit the allotted amount to the special TSB Account opened for the purpose, under intimation to Government. The expenditure in this regard shall be debited to the head of account 4250 - capital out lay on other social services - 00 - 800 - other expenditure - 99 - SDF for MLAs (Plan).
