**ORDER**

Government have introduced National Pension System to AIS Officers (Kerala cadre) recruited on or after 01/01/2004 vide G.O read 1<sup>st</sup> paper above and state government employees who are appointed on or after 01/04/2013 vide G.O read as 2<sup>nd</sup> paper above. Later Government have implemented National Pension System in PSUs/ Autonomous Bodies/ Boards/ Universities as per Government Order read as 3<sup>rd</sup> paper above. Detailed guidelines and accounting procedure to be followed for the realization and upload of backlog contribution in respect of All India Service officers and state government employees pending for the period prior to the commencement of subscriptions of their regular monthly contributions were issued in Government Order read as 4th above.

In the case of PSUs/ Autonomous Bodies/ Boards/ Universities the date of effect of National Pension System and the commencement of deduction of contribution has been varied as per the implementation of NPS in their institutions. At present PSUs/ Autonomous Bodies/ Boards/ Universities etc. transfer backlog contributions by adopting different methods and in order to maintain a uniformity Government are pleased to issue the following.

A unique method similar to G.O.(P) 25/15/Fin. Dated. 14.01.2015 shall be adopted by all PSUs/ Autonomous Bodies/ Boards/ Universities . Number of installments shall be limited to the difference of the number of months from the date of implementation of NPS and the commencement of deduction of NPS contribution. Interest shall also be allowed as stipulated in G.O read as 4<sup>th</sup> paper above.


