S.R.O. No. 388/2016.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

1. *Short title and commencement.*—(1) These rules may be called the Kerala Service (Third Amendment) Rules, 2016.

(2) They shall be deemed to have come into force on the 21st day of June, 2014.

2. *Amendment of the Rules.*—In Part III of the Kerala Service Rules,—

In rule 120.—

(i) for the words, “long after”, the words “after three years” shall be substituted.

(ii) The following shall be added at the end “No Government sanction is necessary, if the pension is granted within three years from the date of retirement”.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per the existing provision in Rule 120 of Part III of the Kerala Service Rules, if under special circumstances a pension is granted long after an employee has retired, retrospective effect should not be given to it without special orders of the Government which granted it, in the absence of special orders, such a pension takes effect only from the date of sanction. Government vide G. O. (P) No. 236/2014/Fin. dated 21-6-2014 have ordered that the word ‘long after’ in Rule 120 Part III Kerala Service Rules will be replaced with ‘after three years’. The following sentence was also included in Rule 120 of Part III Kerala Service Rules. ‘No Government sanction is necessary, if the pension is granted within three years from the date of retirement’. The Government have decided to amend Rule 120 of Part III of Kerala Service Rules thereby to give statutory validity to the modification made as per the said Government Order.
