ORDER

Pursuant to the Government Order read above, Government hereby make the following amendments to Kerala Financial Code Volume I, with effect from 1-4-2006.

AMENDMENT

(C. S. No. 02/2016)

In the Kerala Financial Code Volume I,

(i) In Article 245(a), the words and figures 'whose pay does not exceed Rs. 1219' shall be substituted by the words and figures 'for those drawing a basic pay below Rs. 8390'.

(ii) In Article 245(c) (iii), the word and figure 'Rs. 1000' shall be substituted by the word and figure 'Rs. 2000'.

(iii) In Article 254(1), the words and figures 'drawing a pay not exceeding Rs. 599' shall be substituted by the words and figures 'drawing a basic pay below Rs. 10790'.

(iv) In Article 254(3) the word and figure 'Rs. 100' shall be substituted by the word and figure 'Rs. 200'.
