ORDER

In pursuance of orders issued in the Government Order read above and also consequent on the introduction of new procedure adopted for issuing orders on Reappropriation/ Resumption for the final settlement of appropriation, Government are pleased to issue the following amendments to the Kerala Budget Manual.

AMENDMENT

C.S.No.1/2016

1. The following sentence shall be inserted immediately after the first sentence in Para 93(1) of Kerala Budget Manual.

“Provided that Finance Department may issue orders for final settlement of appropriation by way of Reappropriation/ Resumption of provisions after the expiry of the financial year also, but before the finalisation of accounts by the Accountant General, based on the actual expenditure incurred under each unit of appropriation, as reported by the Controlling Officers”.

2. The figure and words “15th February” in Para 93(1) (i) shall be substituted by the figure and words “10th March”.

3. The figure and words “25th February” in Para 93(1) (ii) shall be substituted by the figure and words “20th March”.

4. The amendment shall be deemed to have come into force on 29.01.2016.


