FINANCE DEPARTMENT—IMPLEMENTATION OF AICTE SCHEME IN GOVERNMENT AND AIDED POLYTECHNIC COLLEGES— MODIFICATION - ORDERS ISSUED

ORDER

As per Government Order read as 1st above, detailed guidelines have been issued for placement of qualified teaching faculties such as Lecturer, Head of Section and Principal in Government and Aided Polytechnic Colleges, into AICTE scheme. The present AICTE scales of pay came into force with effect from 01.01.2006 and as the teaching faculties in Polytechnic colleges in the State have already enjoyed a revision of their scales of pay by merging Dearness Allowance as on 01.07.2009 and also the benefits of service weightage, fitment benefit etc, after 01.01.2006, they were placed into the AICTE scheme on 01-07-2013 by protecting their salary in the State scale.

2.Government have examined the issues relating to implementation of AICTE scheme in detail and are pleased to sanction a hike of 0.25% for each completed year(rounded to nearest multiple of 10), on AICTE pay(without AGP), in the fixation table appended to the Government Order read as 1st paper above, to the incumbents who got a benefit of less than

Rs.6000/- only, on placement into AICTE scheme as on 01.07.2013,subject to the following conditions.

i)Service of the incumbent as on 01/07/2013,in the category of Lecturer and equivalent cadre alone will be considered for hike.

ii)In the case of the categories of Heads of Departments and Principals, the service in the cadres of Heads of Departments and Principals as on 01.07.2013 only will be considered for hike.

iii)For the incumbents who are eligible for hike of their AICTE pay on placement,the modified AICTE pay sanctioned in this order will be treated as 'the AICTE pay on placement into the scheme',for all purposes.

iv)This benefit will be applicable only for initial placement into AICTE scheme on 01.07.2013 only and will not be available in future pay revisions.

An illustration of the calculation of Modified AICTE pay is given below.

The monetary benefit on modified AICTE pay will be from 01.07.2013, ie

the date of original placement into AICTE scheme. The placements already made will be reviewed accordingly.
