### ORDER

Government of India in its letters read as 1<sup>st</sup> and 2<sup>nd</sup> paper above have released an amount of **Rs.53,48,50,000/-** (Rupees Fifty Three Crore Forty Eight Lakhs and Fifty Thousand Only) and **Rs. 1,47,10,000/-** (Rupees One Crore Forty Seven Lakh and Ten Thousand Only) to the State Government of Kerala as central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) Scheme during 2016-17. The amount has to be released to Kerala State Rural Roads Development Agency.

2. Government after having examined the matter in detail, are pleased to authorise the Commissioner, Rural Development Department to release the total amount of **Rs. 54,95,60,000/-** (Rupees Fifty Four Crore Ninety Five Lakhs and Sixty Thousand Only) to KSRRDA being the Central share under Pradhan Mantri Gram Sadak Yojana (PMGSY) Scheme during 2016-17 as detailed below:

4. This transfer of fund is exempted from all the existing treasury restrictions.


