**ORDER**

1. Government have upgraded certain posts of Civil Surgeon Grade I as Deputy Director of Health Services with monetary benefit from 01.01.1995 and abolished the post of Civil Surgeon Grade II as per G.O read 1<sup>st</sup> above. The benefit of the orders have been limited to those who were in service as on 01.03.1992.

2. Several representations were received from doctors who retired prior to 01.03.1992 as Civil Surgeon that their pension be revised corresponding to the scale of pay of Deputy Director of Health Services.

3. Para 3.9 of Government Order read 3<sup>rd</sup> above states that if the post held by the pensioner at the time of retirement/death while in service is no longer in existence in the Department from which he retired or if the category to which the pensioner belonged have moved to other scales of pay after his retirement/death

while in service or if the designation of the post has changed in such a way that it is no longer possible to ascertain as to which is the revised scale corresponding to the post from which the pensioner retired, the revised basic pension shall be fixed based on the corresponding scale of pay over successive pay revisions as indicated in Schedule III of Government Order read 3<sup>rd</sup> above. As per Schedule III of Government Order read 3<sup>rd</sup> above, the Civil Surgeons Grade I is eligible only for the scale of pay 29180-43640.

4. Government have examined the matter in detail and observed that in 1988 Pay Revision the pay scales of Civil Surgeon Grade I is equivalent to pay scales of Assistant Director of Health Services/Deputy District Medical Officer/Zonal Malaria Officer/Principal of Public Health Training School. In 2004 Pay revision the scale of pay of above categories is 16650-23200 and in 2009 Pay Revision the scale of pay of the above categories is 36140-49740 and in 2014 pay revision the same revised to 68700-110400. Government after adopting equivalent pay scales to similar designations are pleased to order that in case of Civil Surgeons retired prior to 01.03.1992 pension shall be revised in the scale of pay 68700-110400.

6. The monetary benefits pursuant to this order shall be with effect from the date of this order only.
