ORDER

Government of India in its letter read as 1st paper above have released an amount of Rs. 11,37,00,000/- (Rupees Eleven Crore and Thirty Seven Lakh only) [General-10.13 crore, SCP-1.11 crore and STP- 0.13 crore], as 1st instalment of Central Share for 2016-17 for implementation of IWMP projects under Watershed Component of Pradhan Manthri Krishi Sinchayee Yojana (PMKSY) in Kerala State. It is requested to transfer this fund with State Share to State Level Nodal Agency for IWMP. The funding pattern between Centre and the State is 60:40.

2. Government vide G.O. Read 3rd paper above had authorised the commissioner, Rural Development Department to release an amount of Rs. 16,88,33,333/- (Rupees Sixteen crore Eighty Eight lakh Thirty Three thousand Three hundred and Thirty Three only) to the Project Directors of IWMP, Kerala being 1st instalment of Central/State share (General) for the implementation of IWMP Projects under Watershed Component of PMKSY for the year 2016-17. Since there is no break-up of SCP & STP components in the Budget provision, it was ordered that sanction will be issued for release of funds to that components soon after re-appropriation.

3. Government vide G.O. Read 4th paper above have sanctioned re-appropriation of funds under the SCP and TSP component for the implementation of IWMP Projects under Watershed Components of the PMKSY Scheme.

4. In the circumstances, Government are pleased to authorise the commissioner, Rural Development Department to release an amount of Rs. 2,06,67,000/- (Rupees Two crore Six lakh Sixty Seven thousand only) to the Project Directors of IWMP, Kerala being 1st instalment of Central/State share (SCP & STP) for the implementation of IWMP Projects under Watershed Component of PMKSY for the year 2016-17 as detailed below.
