**ORDER**

Government, in its order read as 2<sup>nd</sup> paper above, have sanctioned the payment of Social Security Pensions for the month of August 2016 /Advance for the month of September 2016 including arrears. It is reported that all District Co-operative Banks have completed the login with IKM sevana software.

In order to ensure the hassle free transfer of funds an amount of Rs.700 crore was sanctioned as per GO read as 3<sup>rd</sup> paper above to the District Co-operative Banks for the disbursement of Social Security Pensions through the District Co-operative Banks (DCB) / Primary Agricultural Credit Societies (PACS) and other Credit Cooperatives for the month of August 2016 /Advance for the month of September 2016 including arrears.

3. In the review meeting held by Government on 27/8/2016, it was reported that further release of funds is required to ensure the steady flow of disbursement in the field.

4. Government after having examined the matter in detail and are pleased to release Rs. 268.00 crore as Second installment of Funds for payment of Social Security Pension as detailed below.
