**ORDER**

Government in its order read as third paper above have sanctioned the payment of Social Security Pensions for the month of August 2016 /Advance for the month of September 2016 including arrears through the District Co-operative Banks (DCB) / Primary Agricultural Credit Societies (PACS) and other Credit Cooperatives. Interalia, Government have instructed that the funds required for the payment will be released on receipt of data from IKM through DBT cell.

2. The Director of Panchayats has reported that they have released four instalments of funds from the amount available in the A/c No.67234515304 maintained for this purpose at SBT Main Branch, Thiruvananthapuram in the name of Director of Panchayats.
