Authorisation of DA to re-employed pensioners based on general letter of authority issued by Accountant General - Orders issued.

ORDER

As per the reference first cited, Government have issued orders modifying the procedure for fixing the re-employment pay under Rule 100, Part III, KSR. Based on this, the re-employment pensioners are eligible for DA on re-employment pay.

2. As present, enhancement in DA in respect of the re-employed pensioners are done based on individual authorisations issued by the Accountant General. In the wake of the new procedure referred above, the Principal Accountant General (A&E), Kerala vide letter read above has suggested that enhancement in DA can be permitted based on the general letter of authority issued by the Accountant General. It is also requested to issue suitable amendments to Note (2) below Rule 165 (d) of Kerala Treasury Code Volume I, in this regard.

3. Government have examined the matter in detail and are pleased to modify the Note (2) below Rule 165 (d) of Kerala Treasury Code Volume as follows.

"In the case of payment of dearness allowance and other allowances to the Gazetted Officers sanctioned by Government from time to time, a general letter of authority shall be issued by the Accountant General to the Treasury Officers authorising them to make payments thereof to the gazetted officers on the basis of the rates prescribed by the government without a specific authority from the Accountant General for each individual case. Re-employed pensioners are also eligible for payment of DA at enhanced rates based on a general letter of authority issued by the Accountant General".

4. Necessary amendment to the relevant rule in KTC will be issued later.
