**ORDER**

Government in its order read as 3<sup>rd</sup> paper above have sanctioned the payment for the distribution of Social Security Pensions to the Primary Agricultural Credit Societies (PACS) and Other Credit Co-operatives @ Rs.50/- per pensioner. Government have further modified the order vide GO read as 4<sup>th</sup> paper above for the rate of payment.

2. As Government is providing this fund as an incentive to PACS for their committed service in distributing pensions in time, the term 'service charge' used in the G.O would be inappropriate. Therefore the term 'service charge' mentioned in the orders read as 3<sup>rd</sup> and 4<sup>th</sup> papers above needs to be modified as 'incentive'.

3. Government after having examined the matter in detail and are pleased to clarify that the nature of the aforesaid payment shall be as an incentive to PACS for the services rendered by them and accordingly any reference to the term 'service charge' shall be read as 'incentive' in the order cited as 3<sup>rd</sup> paper above. The other conditions in the orders read as 3<sup>rd</sup> and 4<sup>th</sup> papers above shall be the same.
