ORDER

As per the G.O. read 1st above, Government introduced Electronic Ledger Account Monitoring System (e-LAMS) to prevent hasty and imprudent expenditure at the fag end of the financial year. Thereafter detailed operational guidelines were also issued for the release and utilisation of the amount posted in e-LAMS vide G.O. read 2nd above. As per G.O. read 4th above, e-LAMS was extended to the financial year 2016-17 also. As per the guidelines prescribed therein, the amount posted in e-LAMS will not be allowed after 30th September of the subsequent financial years. As such the time limit for release of amount posted in e-LAMS during the last financial year (2015-16) is limited upto 30th September 2016.

2. Several requests are now being received for extension of the period for fund release in respect of amounts posted under e-LAMS, especially in the wake of continuous holidays in the month of September 2016. Requests for extension of the period of utilisation in respect of the amount sanctioned under e-LAMS are also received. Such an extension was allowed last year also vide G.O. read 3rd above as per which period of utilization was extended till 31.3.2016.

3. Government have examined the matter in detail and are pleased to extend the period for fund release in respect of amount posted under e-LAMS during 2015-16 till 31.10.2016. The period of utilisation in respect of amount sanctioned through e-LAMS till 31.10.2016 is extended till the close of the financial year ie. 31.3.2017. However no fresh sanction to release funds through e-LAMS will be permitted after 31.10.2016. Bills can be permitted in full or part against the total amount sanctioned in e-LAMS as per requirement.
