ORDER

Government of India in its letters read as 1st and 3rd papers above, have released an amount of **Rs.2,64,64,000/-** (Rupees Two Crore Sixty Four Lakh and Sixty Four Thousand only) and **Rs.21,91,000/-** (Rupees Twenty One Lakh and Ninety One Thousand Only) towards 1st instalment of Central Share for implementation of DRDA Administration scheme during 2015-16 and it is mentioned that the funding pattern between Centre and State is 75:25. Accordingly Administrative Sanction has been issued to release an amount of **Rs.3,52,84,000/-** as Centre and State Share vide G.O. Read as 2nd paper above and **Rs. 29,21,333/-** as Centre and State Share vide G.O. read as 4th paper above. After that Government of India issued an instruction that the funding pattern was revised from 75:25 to 60:40 between Centre and State w.e.f. 01/04/2015, vide letter read as 6th paper. Hence the CRD had requested to release the balance amount of State Share based on the new funding pattern.

2. Government are pleased to authorise the Commissioner, Rural Development Department to release an amount of **Rs.95,54,667/-** (Rupees Ninety Five Lakh Fifty Four Thousand Six Hundred and Sixty Seven Only) to DRDA being the 1st instalment of balance

amount of State Share for the implementation of DRDA Administration Schemes 2015-16 as detailed below:-
