**ORDER**

As per G.O. 1<sup>st</sup> read above, online bill system has been introduced for bills presented by all grant-in-aid institutions. As per the new system, the grantee institutions shall submit their claims to the countersigning authorities concerned and the Drawing and Disbursing Officers (DDOs) under them shall process the claim and submit the bill online to the treasury. Accordingly, Secretaries of Departments concerned were requested to nominate one officer in their department as DDO for processing the claims of all grant in aid institutions under the department. Now Revenue (F) Department vide U.O. Note read above has furnished the proposal for declaring the Under Secretary, Revenue (F) Department as the Drawing and Disbursing Officer for processing the bills of all grant in aid institutions under the department.

Government have examined the matter in detail and are pleased to declare the Under Secretary, Revenue (F) Department as the Drawing and Disbursing Officer for processing the bills of all grant in aid bills under the control of Revenue Department. However the DDO already declared vide G.O. 2<sup>nd</sup> read above, shall process all grant in aid bills under Revenue (Devaswom) Department.
