ORDER

As per G.O. 1st read above, online bill system has been introduced for bills presented by all grant-in-aid Institutions. As per the new system, the grantee Institutions shall submit their claims to the countersigning authorities concerned and the Drawing and Disbursing Officers (DDOs) under them shall process the claim and submit the bill online to the treasury. Accordingly, Secretaries of Departments concerned were requested to nominate one officer in their department as DDO for processing the claims of all grant in aid Institutions under the department. Now Agriculture (Animal Husbandry) Department and General Administration (Minority Welfare) Department have furnished the proposals for declaring the DDO for processing the bills of grant-in-aid Institutions under the respective departments.

Government have examined the matter in detail and are pleased to declare the Under Secretary, Agriculture (Animal Husbandry-F) Department and the Joint Secretary, General Administration (Minority Welfare) Department as the Drawing and Disbursing Officers for processing the grant in aid bills of all the Institutions under the control of Agriculture (Animal Husbandry) Department and General Administration (Minority Welfare) Department respectively.
