As per the G.O. read 3rd above, Government have accorded sanction for opening a Non-interest bearing Special Treasury Savings Bank Account in the designation of the Employees Compensation Commissioner, Thrissur with District Treasury, Thrissur for transferring the compensation deposited under the Employees Compensation Act from Industrial Tribunal, Palakkad to Industrial Tribunal, Thrissur, for transaction of the out station cheques/DDs received from the employers/Insurance companies and for transferring the compensation to the beneficiaries. Now Administrative Department in the e-file read above has informed that the amount to be deposited in the account is the compensation for employees and is not Government money and hence requested to allow interest to the account already permitted.
