**ORDER**

In the Government Order, read as 1<sup>st</sup> paper above, Government have accorded Administrative Sanction for the construction of building for 506 Anganwadis under RIDF XIX scheme of NABARD. Local Self Government (Engineering Wing) Department is the implementing Department for the projects .As per the Government Order read as 2<sup>nd</sup> paper above, the Chief Engineer, Local Self Government Department was declared as the Chief Controlling Officer of the Head of Account '4235-02-102-94-01-Works (PV)'. The Chief Engineer, Local Self Government Department, vide 3<sup>rd</sup> paper read above, has requested to release necessary funds for the construction of 08 Anganwadis in various Local Self Government institutions.

2) Government have examined the matter and are pleased to accord sanction to release an amount of Rs.40,40,000/- (*Rupees Forty Lakh Forty Thousand Only*) to the Local Self Government institutions as detailed in the statement appended, being reimbursement against the expenditure incurred for 08 projects sanctioned under RIDF XIX scheme of NABARD and this additional expenditure has been authorized vide Government Order 4<sup>th</sup> paper read above.

3) The expenditure on this account will be debited to the head of account -“**4235-02-102-94-01(Plan Voted)-Convergence of Pre-School and Pre Primary Education Centres in Anganwadis (NABARD -RIDF)**”.

4) The Chief Engineer, Local Self Government Department shall draw and disburse the amount to the Local Self Government institutions concerned. The State share of the projects shall be met by the panchayats concerned.


