**ORDER**

As per the G.O. read 1<sup>st</sup> above, Government had accorded sanction to open a non-interest bearing Special Treasury Savings Bank Account in the designation of the Project Directors of Poverty Alleviation Unit of all districts except Alappuzha at respective treasuries for a period upto 31.3.2014 and the validity of the accounts was extended upto 31.12.2016 vide Government Orders read 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> above. Now the Secretary, Hill Area Development Agency has reported that most of the works of HADA are nearing completion and some are pending for want of certain procedural formalities and extension of time is necessary and hence requested to extend the validity of the TSB accounts.

Government have examined the matter in detail and are pleased to accord sanction to extend the validity of the non-interest bearing Special Treasury Savings Bank Account in the designation of the Project Directors of Poverty Alleviation Unit of all districts except Alappuzha for a period upto 30.9.2017.
