ORDER

As per Government order read above, Government have issued revised guidelines for the selection of accredited agencies for the execution of public works as recommended by the Selection Committee constituted for the purpose. The revised guidelines envisaged a score board of 100 marks for evaluation of the agencies and provided for the classification of agencies according to their score and also fixed the maximum value of single work and total work at hand for each class of agency.

2)Government, while examining the application of agencies for the extension of their accreditation to 2017-18, have felt the necessity for revising the existing guidelines for the selection of accredited agencies so as to cope up with the latest changes in the execution of public works.

3)In the circumstance, Government, after having examined the issue in detail, are pleased to order the following modifications to the Government Order read above. Accordingly the minimum score for getting accreditation

and the maximum value of single work and the total work at hand for the accredited agencies will be revised as follows.

Evaluation Score (Total score 100 Marks)	Maximum value of a single work (Rs. in Crore)	Total Work at hand (Rs. in Crore)
25-40	7.5	75
41-55	15	150
56-70	22.5	225
71-85	30	300
85 and above	37.5	375
