### ORDER

As per the Government Order read above, Government have adopted Jeevan Pramaan Portal for the State Pensioners and all treasuries and Akshaya Centres in the State have been entrusted with issuance of Digital Life Certificate to the pensioners through this portal. Subsequently, the meeting referred above has discussed the modalities for providing the facility through Akshaya Centres. Accordingly, the Director, Kerala State IT Mission, has submitted revised proposal with cost implications involved in the process.

2. Government have examined the matter in detail and are pleased to issue the following orders.

- (i) Jeevan Pramaan Registration and issuance of Digital Life Certificate (DLC) shall be facilitated at 1500 + Akshaya Centres in the State.
- (ii) Pensioners can visit Akshaya Centres and get Jeevan Pramaan DLC paying the specified service charge.
- (iii) In the case of bedridden pensioners, Akshaya Operators shall visit the pensioner and issue DLC upon request received at Akshaya District Office or at the Akshaya Centre concerned.
- (iv) The service charges involved in the Jeevan Pramaan registration / DLC issuance are listed below.
