ORDER

Government of India in its sanction order read as 1st cited, have released an amount of Rs. 80,54,000/- (Rupees Eighty Lakh and Fifty Four Thousand Only) towards 2nd instalment/restoration of deduction made earlier from the due amount of 2nd instalment of Central Share for implementation of DRDA Administration scheme during 2016-17. It is also instructed to release the fund along with state share. The funding pattern is 60:40 between the centre and the state.

2. Government are pleased to authorise the Commissioner, Rural Development Department to release an amount of Rs. 80,54,000/- (Rupees Eighty Lakh and Fifty Four Thousand Only) to DRDA being the 2nd instalment/restoration of deduction made earlier from the due amount of 2nd instalment of Central Share for the implementation of DRDA Administration Schemes 2016-17 as detailed below:-
