ORDER

Government of India in its letter read as 1<sup>st</sup> paper above have released an amount of Rs.30,00,00,000/- (Rupees Thirty crore only) as material and administrative cost for the implementation of MGNREGA for the year 2016-17. It is directed to transfer the fund along with state share. In the sanction order read as 1<sup>st</sup> paper above, it is specified that the material component is to be shared on 75:25 basis between Centre and state Government. The Mission Director, MGNREGS as per letter 3<sup>rd</sup> read above, has furnished details of matching state share (including administrative expense of State Employment Guarantee Council) of central release based on the Labour Budget 2016-17.

2. Government, having examined the matter in detail, are pleased to accord Administrative Sanction to release an amount of Rs.38,43,26,000/- (Rupees Thirty eight crore Forty three lakh and Twenty six thousand only) being the Central and State share under MGNREGA for the financial year 2016-17 to the state level implementing agency as detailed below:
